4. COURSE VALIDITY PERIOD (COURSE DURATION)

5. LECTURES

7. TEST SERIES

- i. The Test targeted on the new provisions of the Criminal Laws will be conducted in every fifteen days. This test will carry 25 to 50 questions based on the declared syllabus of the new laws.
- ii. All the other tests will be conducted in MPSC pattern through the online mode in the App.
- iii. The PYQ test series will be made available from the starting of the course.
- iv. The MLTS tests series consisting of three tests will be conducted 20 days before the prelims examinations.

8. ONLINE LIVE SESSIONS

- i. Live Doubt Clearance Sessions (DCS) will be conducted once in a week in online discussion mode.
- ii. The Special Live Sessions (SLS) will be conducted through online discussion mode once in fifteen days and will cover techniques for prelims preparation.

9. GENERAL RULES

- i. All the lectures will be provided / conducted through the 'App' of the Academy.
- ii. The lectures can be watched on mobile, computer desktop as well as on laptop.
- iii. The lectures can also be downloaded in the 'App' of the Academy and can be watched offline as per convenient time.
- iv. The lectures will be conducted in mixed language i.e. Marathi and English.
- v. Each lecture can be watched at least three times during the validity period of the course.
- vi. The lectures and study material will be available in the course 'content tab' till the expiry of the Prescribed Validity Period (PVP) of the course.
- vii. The notification of the Doubt Clearance Session (DCS) will be provided on the What's App group of the course. The recording of the DCS will be available during the Prescribed Validity Period (PVP) of the course.
- viii. The schedule of the Special Live Sessions (SLS) will be declared at the appropriate time during the course. The recording of the SLS will be provided after the session and it will be available for the Prescribed Validity Period (PVP) of the course.
- ix. The Prescribed Validity Period (PVP) of the course will be as per clause 4 (i & ii) of these rules. Candidates to note that the technical validity period of the course appearing in the 'App' or any other sources may be different from the Prescribed Validity Period (PVP) of the course. The validity prescribed by these course rules will prevail.
- x. After completion of the Prescribed Validity Period (PVP) the course will not be accessible to the course candidates in any case. The validity period of the course will not be extended.
- xi. All uploaded lectures, recordings of live lectures, tests, test series, etc. will be available for study till the exam date/ the Prescribed Validity Period (PVP) of the course.
- xii. The Academy will form a What's App group of all the registered course candidates. All the information regarding the course will be updated on the said group. It will be presumed that the information has reached the candidate, once it is posted in the said group.
